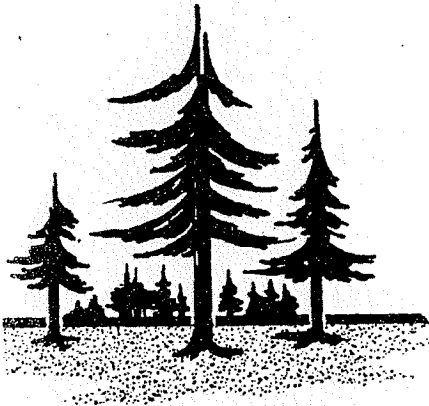

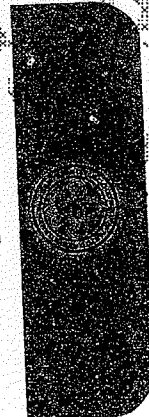

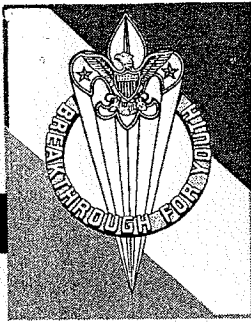

Sir,

The above subjects name came to my attention on an inquiry by a Scout Leader as to the moral character of this subject being associated with the Scouting Program of the Boy Scouts of America. This investigation was initiated by a request from William Maple Boy Scouts of America-Akron Area Council-District Executive to check this subject for a criminal record.

Through pre-information I contacted the Chief Deputy in Portage County and learned that subject was arrested April 2, 1964 on a charge of Petit Larceny in Kent, Ohio (March 7, 1964) Theft of a citizen's band radio from a motor vehicle. He was found guilty and was fined Ten dollars and Costs.

This subject was at one time employed by Radio-TV Station WAKR this city as an engineer. He also had a business called RF Communications Services at 725 Darrow Rd this city (K8oyQ) After he left for Texas, the property owner found the attached pictures in one of the office files (Nine (9) poleroid snaps of a nude juvenile exposing the male sex organs)

In addition from Portage County it was learned that on June 28, 1967 the above subject took one, [redacted] WM 15 7613 Market Avenue N. Canton, Ohio and [redacted] WM 13 on a camping trip (1111 Ivy St N. Canton, O) to the camping area near Mogadore Dam in Portage County. Apparently during a rain storm when all three were in the tent, DAVES attempted to assault [redacted] by feeling his privates and also placing his mouth on [redacted] penis. [redacted] refused to let the act continue. After [redacted] went to sleep, DAVES approached [redacted] and succeeded in the act of Sodomy. Later they all went for a ride. [redacted] became tired of riding around and asked to be dropped off at camp. This was done, and DAVES and [redacted] stayed in the car. DAVES allowed [redacted] to drive the car and [redacted] wrecked the car by losing control and hitting a pole. Both subjects went to the hospital and this initiated the investigation that resulted in the knowledge of the homosexual activities by DAVES.

This subject is currently registered with Pack (Cub) 317 as a Cubmaster in the Eastern Dist. Akron Area Council. Prior to that he was with an explorer post in Cuyhoga Falls. This is actually a matter of record due to the fact that this subject is living in Texas at this time.
