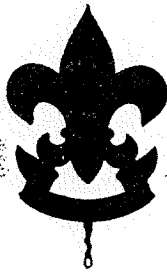


I join with the committee in the opinion that Dierker should not be permitted to be associated with Scouting in any capacity in the future.
