- 1) He is mentally retarded, with an I.Q. of less than 80.
- 2) He is emotionally unstable plus records of Alameda County indicate he has been picked up on several occasions for reckless actions.
- 3) He has acquired an Alameda County Sheriff's Office record for molesting boys and recently undertook surgery, at his request, in lieu of a jail sentence.

For your information his correct name is Charles Bert Dohm; home address, 317 East 17th Street, Oakland, California; 42 years of age; Gaucasian; unmarried; religious preference, Catholic; grammar school education; telephone, GL 1-6589. He was Tast registered as Assistant Scoutmaster of Troop 201, November 1961 date of expiration. He has not reregistered, and we have refused to accept his registration at this office n his current efforts.


