When I came back he was already out in the woods and had the tent set up. Igot my stuff in the tent and laid out my blanket and

pillow. Than he asked me if I wanted to go swiming, I said yes and was with us. Than we went back to the tent we had some coffee sat by the fire and talked for a while.
