NEW PORT RICHEY A New Port Richey man who well unteered his mime to work with Cub Scouts was sen-tenced by Circuit Indge Edward H. Bergstrom Jr. to 15 years frabation Monday for fundling one of his 8-year-old

charges Warren Raymond Foley, 39, pleaded ruilty to the crime He had previously been convicted of sodomy with a juven-

The state's prosecutor argued that Folloy should spend at least a year behind bats because of his background.

But because of new state sentencing guidelines the judge was unable to consider the previous sex crime.

AT A HEARING Jan. 18, Assistant State Attorney Michael Halkitissaid Foley took the 8 year old Gub Spout on a camping trip to Homosassa Springs and fondled the boy's sexual organs through the child's trousers.

On Oct 29, according to court documents, Foley, a security guard who lives with his parents, repeated the incident at the boy's New Port Richey home.

After being arrested Nov. 18, sheriff's deputies reported, Foley admitted fondling the boy and said he had done the same thing previously with two other boys. "The defendant stated that he has a problem that causes him to get the urge

to fondle these young boys and needed help." Foley's arrest report says.

The state and Foley's appointed public defender subsequently agreed to a negotiated plea that would keep Foley

But at the dan, 18 hearing, Halkitis said that plea bad been negotiated before he had learned of Foley's conviction in New York on the charges of sodomy with a juvenile.

At Foley's sentencing Monday, Public Defender Keith Hammond told Bergstrom that his client "was truthful, had admitted his problem," and was regularly attending psychological counseling sessions at the Human Development Center:

BUT ASSISTANT State Attorney Gary Davis then brodght forth information gathered in a background inevestigation on Foley that he thought was cause to deny probation, Davis said Nassau County, N.Y. detectives informed him that Foley had been working with Boy Scouts at the time of his sodomy arrest 20 years ago.

"This man certainly deserves a year in county jail," "Pax's said. "And even that's not enough."

The judge sentenced Follow to 15 years' probation and ordered him not have any contact with children 16 or younger without the consent of his probation officer. Bergstrom also ordered Foley to continue his psychological counseling until he had received "the maximum benefit;" and to perform 140 hours of community service
