Report to Personnel Division National Council, B.S.A. New Brunswick, New Jersey

On Friday, March 1, 1968, I received a call from Mrs. of 3577 N.E. Schuyler, Portland, Oregon, concerning a meeting of young men who were in Sea Scout Ship 684 or who had recently left the ship. She overheard them discussing how they were going to use the nude pictures of the Skipper, (Brian Gagnier) and a young man who used to be in the ship to blackmail him into quitting as Skipper. She pulled her boy out of the ship because Mr. Gagnier was always inviting individual boys to his apartment and wanting them to undress and be comfortable.

I contacted the fathers of the boys who we're at the meeting and arranged a meeting at the Scout Service Center on March 1968. The following young men registered in Sea Scout Ship 684 were present:

and his father , 3584 NE. Broadway, Portland and his father , 1816 NE. 36 Ave., Portland , 2815 NE. Alameda, Portland Father not present.

It was brought out at the meeting that many and numerous events had taken place with members of the ship. Many have recently left the ship because of the Skipper's (Brian Gagnier's) actions. It turned over to me the pictures that were referred to earlier by Mrs.

With this evidence I met with Mr. John Binford, Institutional Representative of the ship, sponsored by Hollywood Lions Club, and informed him of the facts. He agreed that the Skipper must be asked to resign immediately. They want to continue sponsoring the ship and will meet and select a new Skipper.

On Thursday morning I called Mr. Gagnier and asked if he could meet me at the Scout office. He could not, so I went to his place of employment and informed him of my meeting with the parents of Ship 684. He agreed that he must resign, was sorry this even happened and would seek psychiatric help. Attached is the confidential record sheet.
