As you know, because of your past association with Spouting, the Boy Scouts of America is privarily concerned with inculcating its objectives of character development and citizenship training in the lives of youth and registration as a leader in this program is a privilege and not a right.

In keeping with these objectives, the Scouting organization has always reserved the prerogative of accepting applications from those individuals it feels are best qualified to give the kind of leadership that this organization wishes for boys enrolled in the Scouting program.

Occasionally, the Boy Scouts of America decides that, in its best judgment, it is unwilling to accept an application to commission an individual for a leadership role. Whenever it makes this determination it gives nor reasons for this action and this is never intended as a criticism or accusation of any type.

It is my sincere recommendation that if you wish an outlet to any service motivated desires, you saik other channels.


