did then and there unlawfully, feloniously, accost, entice or solicit a child under fifteen years of age, with the intent of he, the said William H. Goatley, to induce or force said to commit an immoral act, or an act of gross indecency, or an act of depravity.

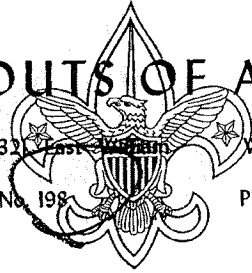
