Thank you for your letter of June 7 concerning John Shelton Guillet, currently registered as advisor of Post 530 in Lafayette. We have placed this information in our files and have taken steps to have his name deleted from the Post roster.

In cases of this nature it is most important that we have as much supporting information in our files as possible in order to justify our refusal to accept any future registration applications from the individual involved. Therefore, if at all possible, we would very much appreciate your forwarding to us any substantiating documents that may be available regarding this situation, such as a statement from the boy involved, or the police officer who witnessed the incident. This additional material will enable us to identify Mr. Guillet should he ever again attempt to register in the Scouting program. Thanks for your help.

I am sure you realize that this leaves Post 530 without any registered unit leader. Undoubtedly, someone is taking over in this position. In order for the unit to continue to receive program inserts in Scouting Magazine, it will be necessary to advise this office of the name of the new unit leader. This should be done by filing with us an additional enrollment for this individual in his new position. Please do not file a separation notice as we have already dropped the current leader.
