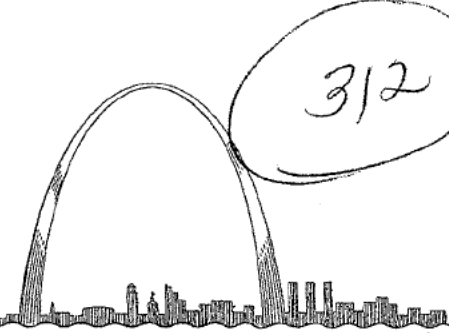

Dear Bud:

I appreciate your taking time today to discuss by phone a mutual problem and look forward to our meeting Monday night where we can discuss in depth a course of action which will be desirable to all parties concerned.

As to the purpose of this letter, I wish to advise certain information and actions already taken, plus a recommended course of action for you, as Deputy Scout Executive, to follow.

1. Mr. Howard Gupton, Scoutmaster, Troop 783, Ballwin, Missouri has been relieved of his duties as of Saturday morning, June 21, 1969.
2. The action was taken in view of information furnished which, in the opinion of myself and all undersigned parties, questions the ability and moral character of Mr. Howard Gupton.
3. As a matter of record, this man is in the custody of the Sheriff's Office at Farmington, Missouri pending prosecution.
4. The undersigned also recommend the only course of action for the Boy Scouts of America to follow would be to go on record officially that this man is no longer morally fit to serve in any capacity with the Boy Scouts or any other youth organization, and that this information be placed where it is accessible to any responsible party or parties inquiring as to this man's fitness to serve.

Bud, I wish that you would confirm in writing to me the course of action which will be followed by your office.

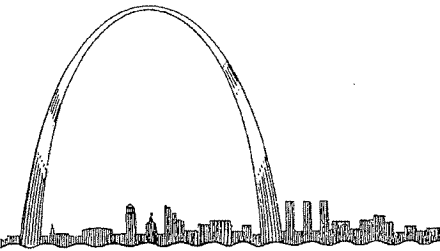
