In reply to your letter of the twenty-seventh, in regard to Mr. Hladke, it is with regret that I must report to you that he was dismissed from employment at the priversity of Florida for tampering with the mail and is not eligible for recemployment with this institution.

The nature of his offense consisted primarily in removing foreign postage from incoming mail, and replacing the removed stamps with postage due stamps. This meant the University was losing various amounts in Due Postage as these thets occurred, plus the delay in the mail reaching the addresse. This may have been done with the best of intentions perhaps that of accumulating foreign stamps to help some Scouts with their stamp collections. We do not know for sure whether he made money by selling the stamps, or whether he was giving them away.
