It is requested that all Scouting records pertaining to Sergeant Jon Jackson, Scoutmaster, Boy Scout Troop 127, Fort Hood, Texas, be flagged to preclude his further participation in the Scouting Program.

Bases for requesting this action are the acts of homosexuality committed by Sergeant Jackson toward Scouts registered with the troop. Statements received from each Scout are attached. Their home address is listed below.

Action has been taken to remove Sergeant Jackson from the Scouting Program sponsored by this installation and to suspend all Scouting awards received while in the program. In addition, a formal investigation has been initiated by military authorities which should result in his being discharged from the Army.

We spent the ~~on~~ night at the Scout House, other scoutmasters

Mr. Stamper, Mr. Griffis, Toby, and one other so scoutmaster were in their rooms and did not know anything about it.

Jack turned out the lights and said, "You want to be among the older boys, you want to learn something the older boys know."

"This will only take about five minutes."

Then he made me take off all my clothes.

Then he started to squeeze my private organs.

Then he put hand on his private organs, and made me squeeze them.

I told him that I didn't like that.

He said, "Give me a reason why." I said that just didn't like it. Jack turned the light on and I put my underwear on and turned on my stomach. Then he turned out the lights and said, "You're not going to on me and then he did it again."

Then I went to sleep. The next morning he took brought me home. He made promise not to tell anyone or he would not take me out with the older boys any more.

Another time I went with him to pick up his clothes at the barracks. We drove out on the back road by the motor pools toward the airport. He ~~me~~ made me sit close to him and take my pants and my

Another Friday night after a scout meeting in August.

This time he did not make me take off my underwear. He played with my private organs but he did not make me play with his.

I told him I didn't like this and he asked why. He said, "If you want your Patrol Leader, Dave, you will have to keep this up

one night in my room (the last week in August.) He started to squeeze my private organs. My mother knocked on the door and he stopped.

On Friday 1 Sept, before I left for alabamas he he asked, "Do you want to keep this up after you get back?"

On Monday night 4 Sept, he came into my room and said, "Have told anybody yet?" I said "no." He started to squeeze my organs again, I hope that some one would come in but no one did.

On Friday night 8 Sept after the scouting meeting. he called me into the rest room at the scout house. He leaned on the door so no one could get in and started to squeeze my private organs. He said, "Do you want to keep this up?"

During the last Spring Camporee Mr Jackson asked me to go to the Scout house with him from Killen Base to get Signal Flags for the troop. We went into the troop room at the Scout house. While we were there he grabbed my private parts and asked me to do the same to him. I pulled away and he said "what's the matter?" When we were in the car on the way back to Killen Base he grabbed my private parts again and I said "Lay Off". On one occasion after that he was driving me home from Scouts and he said "what would you do if I asked you if I could blow you?" I said "How do you ~~you~~ get your kicks out of that?" He said "If I do ~~it~~ ~~an~~ ~~return~~ it to you I expect something in return". Then I said "Forget it".

My name is [REDACTED]. I was born on June 1, 1954.

About May 19, 1967 about 11 PM Sgt Jon Jackson, Scoutmaster, Troop 127, Ft. Hood, Texas, asked me into the committee room at the Scout House on Fort Hood. The boys going to Philmont were sleeping there for a practice hike the next morning. He locked the door and told me he wanted to show me two bones rise in my penis area. He then asked me to remove my pants. I refused. He kept at me and then threatened me with something of minor detail I can't remember. I took my pants off and he began massaging my belly. He then switched to my penis and 10 minutes or so later I ejaculated and he quit.

July 13, 1967 he took me to Camp Tahauya for Order of the Arrow tap out. He turned off on a road that runs behind the camp, stopped and told me to "drop my droops." I said no. He then threatened to see that I wouldn't be tapped out. He tried to make me ejaculate for about 5 minutes but failed and we went on into camp.

He has tried on other occasions but failed.
