Yes, we have the right identification on Carl R. Jones. He was placed with us from the Georgia-Carolina Council in August of 1967.

He was on the summer camp staff of that council, but he conducted some undesirable acts with boys and after an investigation by the military authorities, he was discharged from the U.S. Army at Fort Gordon on August 1, 1967 for reasons which I do not have to spell out in clear words. As a result of this, we regret to advise you that we cannot accept his registration in the Boy Scouts of America.

I made an appointment with him and spent an hour last night going over his record (with Martin Latimer, A.D.S.E. present).

Since I do not recall putting Carl on the Confidential List, we assume that the Georgia-Carolina Council did so. He was an Assistant Scoutmaster of Troop 99 at Fort Gordon, Georgia while in the Army. During the summer of 1967, he served as one of the troop leaders of Troop 99 and as a Camp Commissioner for the Council camp.

Carl is a negro, 6'3", weight 185 lbs, born Feb. 13, 1947, so we assume you have the right identification?

We would appreciate having confirmation that this is the same man and that he is on the Confidential List.

During our summer season at Camp Linwood Hayne one Carl Robert Jones committed some undesirable acts with boys. Since he was acting as an assistant leader of Troop 99, sponsored by Fort Gordon, the Provost Marshall, Lt. Col. Billy J. Shuman, conducted a discreet but thorough investigation.

Jones was discharged from the U. S. Army at Fort Gordon on August 1, 1967 as a result of having been found to be a homosexual. His registration with Troop 99 was in the works, but had not reached the council office.
