

Dear Mr. Wilson:

Mr. John MacLardie was seen for psychiatric evaluation through our psychiatric team approach. We find him to have a personality disturbance associated with traumatic experiences in early childhood, particularly the death of his father in an auto accident, and the accidental death of a younger brother. He has experienced some confusion over mascrifine identification, especially earlier to adolescence, but has, for the most part, made an adequate adjustment. The incident which led to his recent arrest may best be understood as an impulsive, regressive act, linked with certain self-defeating aspects of his personality.

It is felt that Mr. MacLardie can benefit from psychotherapy, and he has begun treatment with one of our staff.
