This is to advise you that Donald E. Miles, age 28, of 1006 N.E. Second Street of Washington, Indiana has resigned as Scoutmaster of Troop #76 sponsored by St. Simons Catholic Church of that city.

This resignation was prompted by the demands of the parents of several boys who also insist that Mr. Miles be prevented from having any future association with Boy Scouting.

These parents have submitted written statements from their sons which indicate that Mr. Miles attempted to engage the boys in obscene conversation and did commit unnatural acts in their presence on Saturday night, September 2, 1967.

Mr. Miles was informed of the seriousness of his actions and was advised and counselled by the Very Reverend William Lantner, Pastor of St. Simons, and by [REDACTED], M.D., one of the boys father.

If any further information is needed please let us know.

Sir:

On Sat. Evening Sept 2+3, 1967, between hours of approximately 11:30 to 1:30 a.m., while camping at Columbia Mo., enroute home from our O. A. trip to Nebraska, my tent was approached by Mr. Ron Myles, adult leader, of Washington, Indiana. In the presence of me and my tent mates, [redacted] of Bedford, Ind., [redacted] of Paoli, Mr. Myles during his approx. 2 hour stay, told lewd and obscene stories, attempted to get the 4 of us to engage in obscene games with him, and made lewd and obscene physical contact upon my private body as well as displaying himself in ^{auto} sexual acts. Because of ~~my~~ physical fear of Mr. Myles due to this behavior, I and my tent mates were frightened to know what to do or report this until

we were nearly home and had left

Subject Mr. Roy Miles; an adult chaperone
Near Sir:

The following is a true statement of
incidents that occurred on the trip to
and from The National Conference, Order
of the Arrow meeting at Lincoln, Nebraska.

On the bus going to Lincoln from Bloomington
he was passing around sex literature and
obscene books from a plastic folder he had
in his possession. After we arrived at
Lincoln I never saw him except when he came
to Mr. Bob. Masts room for meetings as he was
in a different room.

On the return trip from Lincoln to Bloomington the
second day of travel he again proceeded to pass
around obscene literature and at The Columbia
Court in Columbia Missouri he came to the
tent in which I was billeted with three
other boys from Pauli and began by telling
dirty stories, his experiences in the armed
services, and also about how he lost his arm
while in the service of the United States. In
his stay in our tent he tried to persuade

myself or one of the other three boys to go to the shower with him after the other two leaders had retired for the night. The time spent in our tent trying to get one to go out with him was from about 11:30 pm until 1:30 AM. Not being able to get one of us to accompany him, as we were scared, he then made passes at me that were sexual in nature. He also tried to convince Mr. [REDACTED] to accompany him and could not get him to do the same. Once when [REDACTED] left the tent to use the restroom this Don Miles followed him and made attempts of indecent sexual approaches to him. After [REDACTED] returned to the tent Miles returned again to our tent and tried to get us boys to put money in a circle and whomever could master ball the fastest was the winner of the money, he bragging that he could do same in 9 seconds. We boys all huddled close together in our sleeping bags, all the time from 11:30 pm until 1:30 AM, telling him to leave our tent, he finally became disgusted and went out of our tent and masturbated in front of our tent and walked on down toward the leaders camping trailer which was close to a night light and presumed to relieve himself again. He then

went into the trailer to bed. One the night
and last day enroute home he again proceeded
to pass around some more books and obscene
pictures to the boys in the bus. As to my
knowledge he never touched anyone physically
that day. I think it would be a good
idea to check with the boys from Bedford,
Blington & Washington to see if he made improper
advances at these boys also. The above is a
true occurrence that happened to me.

son who is a minor, exactly as he told me and
I would like to see some action on the same taken
where this homosexual son-of-a- [REDACTED] will be taken
out of young peoples lives. I trusted that my
son would be in good grown-up hands on the
trips that he takes with the Scouts. I cannot
speak highly enough about our Scout master Bob
Must, as he is doing one very very good job in
Scouting in Paoli. If I could hold my temper I
would like to meet this Don Mills face to face.
