Pleas Entered By Defendants In Circuit Court

Pleas have been entered by individuals involved in Tuesday's indictments by the grand jury with hearings to follow for those requesting probation and trial dates set for those pleading not guilty.

Four persons plead guilty, three on one indictment, before Judge D. E. Cuppett Jr. this morning.

William T. Davis, William E. Miller, and Harrison Loveless, plead guilty to the charge of breaking and entering the North End Grocery here and each was sentenced to terms of one to 10 years in the state penitentiary. However, a hearing on requested probation will be held later before the court.

John Joseph Monohan, indicted on a charge of sodomy, plead guilty to the charge and a probation hearing was set for later today.

Pleading not guilty were Paul R. Flanagan and George Fink, both indicted on a charge of driving while intoxicated. Flanagan's trial has been set for Jan. 30 with Fink's set for Feb. 2.
