
Dear Howard,

him to do this.
Suspect Musser was booked for investigation of molestation. Held
for CAU.
Juvenile [redacted] was taken to Youth Bureau and left in their
custody.

Statement of John William Musser, taken in the office of the General Assignment Unit of the Kansas City Missouri Police Dept., located at 1125 Locust, Kansas City Missouri, by Det. George Jeter, on October 10th, 1968, at 0930 hours.

Q. What is your full name?

A. My full name is John William Musser.

Q. When and where were you born?

A. I was born 7-30-27, in Lawrence Kansas.

Q. Where do you live, and what is your telephone number?

A. I live at 712 E. 45th Terr., North, Kansas City Mo., my telephone number is GL2-2165.

Q. With whom do you live?

A. I live with my wife Dorothy, and four children.

Q. Where are you employed, and how long have you worked there?

A. I work for the Western Union, located at 7th and Walnut, K.C.MO, as a maintance man, for the past 23 years.

Q. Have you been advised that you do not have to make a statement, and if you do, anything you say can be used against you and that you have the right to consult with friends or an attorney?

A. Yes Yes.

Q. Under these conditions do you want to make a statement relating to the molestation of [redacted] w.m., 15 years, which occurred on 10-9-68, which was reported on police report number 841-514.

A. Yes Yes.

Q. Will you then tell me exactly what happened on 10-9-68, and how this incident occurred?

A. Yes Yes.

At approximately 7:00 PM on 10-9-68, I went to the home of [redacted] who lives at 528 N.E. 44th Terr, and who is a neighbor boy of mine that I have known for the past 2 months. This boy had been helping me put roofing on my house, so I went to his home to take this boy to the penny arcade to reward him for helping me. When I arrived at this boys home, his parents were there and they gave the boy permission to go with me, and not to stay out any longer than 10:00 PM. At this time the both of us left in my car, and drove to the penny arcade located at 12th and Grand K.C.MO, where we stayed there for approximately one hour. After we left the penny arcade, we drove to the Quality Hill lookout, to let this boy watch the airplanes at the airport through the telescope at this location. We ~~stayed~~ stayed there for approximately 20 minutes, and then we left. After the both of us got into the car, I put my hand on the boys leg, and asked him if it bothered him. The boy said no, so I then put my hand the boys penis, and he said that it felt good. At this time the boy put his hand on my penis. At this time we drove around for awhile, and then drove to a parking lot in the vicinity of 15th and Hickory, where we drove to the rear of the parking lot and parked. After we parked, I lowered the back seat, and the two of us climbed into the back seat and removed our clothing from the waist down, and began playing with each others penis. We were there for about 10 minutes, when the police arrived and had the both of us get out of the car where they placed us under arrest, and were taken to the police station.

Q. Is there anything else that you want to say in connection with this incident or to any other similar incidents?

A. Yes Yes, I wish to state that I have performed similar acts on this same boy before, and also to other boys.

Q. Will you read and sign this statement?

A. Yes Yes, I have read the above statement consisting of one page, I
