Yos. At approximately 7:00 PM on 10-9-68, I went to the home of who lives at 528 N.E. 44th Terr, and who is a neighbor boy of mine that I have known for the past 2 months. This boy had been helping me put roofing on my bouse, so I went to him home to take this boy to the penny arcade to reward him for helping me. When I arrived at this boys home, his parents were there and they gave the boy permission to go with me, and not to stay out any longer than 10:00 PM. At this time the both of us left in my car, and drove to the penny arcade located at 12th and Grand K.C.MO, where we stayed there for approximately one hour. After we left the ponny arcade, we drove to the Quality Hill lookout, to let this boy watch the airplanes at the airport through the telescope at this location. We are stayed there for approximately 20 minutes, and then we left. After the both of us got into the car, I put my hand on the boys leg, and asked him if it bothered him. The boy said no, so I then put my hand the boys penis, and he said that it felt good. At this time the boy put his hand on my penis. At this time we drove around for swhile, and then drove to a parking lot in the stringty of 15th and a Hickory, where we drove to the to a parking lot in the vicinity of 15th and Millokory, where we drove to the rear of the parking lot and parked. After we parked, I lowered the back seat, and the two of us climbed into the back seat and removed our clothing from the waist down, and began playing with each others penis. We were there for about 10 minutes, when the police arrived and had the both of us get out of the car where they placed us under errest, and were taken to the police station.

A. Is there anything else that you want be say in connection with this incident or to any other similar incidents?

A. The Yes, I wish to state that I have performed similar acts on this same boy before, and also to other boys.
