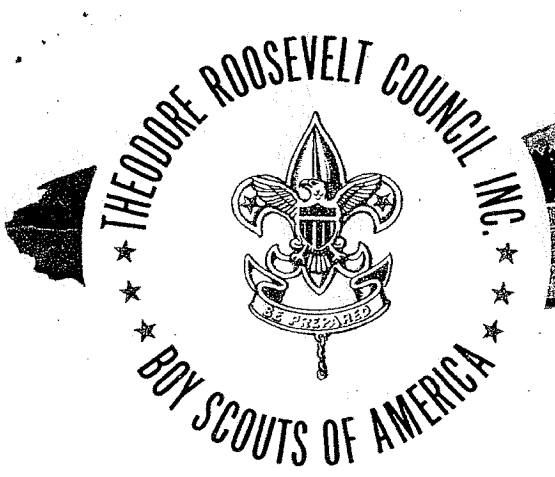

The Loitering charge was dismissed but he was found guilty of the charge of Indecent Acts and was sentenced to 16 days in jail or \$50.00. He paid the fine.

Mr. Olson has since been transferred to the Los Angeles office of his firm. He was employed by Phoenix Cement Division of American Cement Corporation, 3550 No. Central, Phoenix, Arizona.
