GENERAL COURT-MARTIAL ORDER NUMBER 14

The sentence was adjudged on 17 May 1966.

In the foregoing case of Specialist Four E4 Mitchell P. Brovost, RA 22 909 565, U. S. Army, 3d Enlisted Student Battery, Enlisted Student Battalion, School Support Command, U. S. Army Air Defense School, Fort Bliss, Texas, only so much of the sentence as provides for dishonorable discharge, forfeiture of all pay and allowances, confinement at hard labor for 5 years, is approved. The forfeitures shall apply to pay and allowances becoming due on and after the date of this action.

The record of trial is forwarded to The Judge Advocate General of the Army for review by a board of review.

Pending completion of appellate review. The accused will be transferred to the United States Disciplinary Barracks, Fort Leavenworth, Kansas.
