Report on Undesirable Conduct of Mr. Robert H. Scanlan While on a Troop Camping Trip in June of 1967.

Troop 99 of Downers Grove, Illinois went on a camping trip to the Yorkville Scout Reservation of the Chicago Area Council in June 1967. There were five Boy members of the Troop on the activity and Mr. Robert H. Scanlar, the Scoutmanter.

The situation was described that Mr. Scanlan, on an occasion during the camping trip, separated one of the Scouts from the group. He had the Scout remove all his clothing under a so-called initiation as his Green Bariteader. He had the Scout run around through the vegetation. The Scout was fonded by Mr. Scanlan, which involved the genital organs. The Scout was told by Mr. Scanlan that he should tell no one what had occurred in the so-called linitiation. On the Scout stating that he would tell his parents, Mr. Scanlan his him, indicating he would get additional such treatment if he did any talking about what had occurred to him. On one other situation in the above described occurrence Mr. Scanlan struck the boy.

The above matter was brought to the attention of the Scout Executive through an informant on September 12, 1967. An immediate investigation was made by sessions with key personnel of the Troop and neighborhood.

On Saturday afternoon, September 16, 1967, a meeting was held with Mr. Scanlan at the Council Service Center. Present with the Scout Executive was the Assistant Scout Executive, William Monical. Mr. Scanlan was given a description of the occurrence described in the second paragraph of this report. Mr. Scanlan admitted the situation. He stated that at the time he had been doing some drinking and had been taking drugs. He also made a statement of having marital difficulties at the time. He further stated that shortly afterwards he sought psychiatric help and has had six or seven treatments since the incident occurred. He accepted the instruction that he no longer would be registered as a Scouter. He indicated he presently was concerned with a possible move away from the community because of a change in job circumstances.
