



On Tuesday afternoon, February 24, 1970, I received a telephone call from [REDACTED], Institutional Representative, Christ Congregational Church, regarding Joel Sheffel, Cubmaster of Pack 3094 sponsored by this church.

A Mrs. [REDACTED], mother of a Cub Scout in Pack 3094 had contacted Mr. [REDACTED] regarding an incident which occurred at a Webelos Den Meeting on Monday evening, February 23. It is reported that Mr. Sheffel informed several boys they would be initiated into the pack that evening. These boys were then taken to an adjoining room and were told to undress. Mr. Sheffel then proceeded to fondle several of the Cubs.


I immediately tried to contact Mr. Sheffel but was unsuccessful until 11:00 p.m. Tuesday evening. Mr. Sheffel admitted to me that the above report was true and asked what steps he should take. I advised him to resign from all Scout activities and to submit a resignation to me to that effect. Mr. Sheffel assured me that this resignation would be in the mail the following morning.

I have contacted all sponsoring institutions in which Mr. Sheffel was associated and have informed them that Mr. Sheffel has resigned from Scouting and would not be attending future Scout meetings and activities.

I am attaching Mr. Sheffel's resignation. I would professionally recommend that Mr. Sheffel's name be placed on our National Confidential List [REDACTED]
