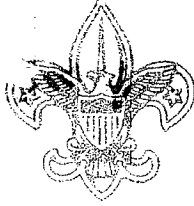

He is a graduate of West Chester State College and was a sixth-grade teacher in the Main Street Elementary School. He is married--age 26 - no children. He is approximately 6 feet tall--170 lbs. - black hair--brown eyes. He is currently listed as Scoutmaster of Troop 274, sponsored by the Upland P.T.A., Upland, Pennsylvania. That charter expires November 1966. Attached are two newspaper clippings regarding Thorpe's actions.

Teacher
Accused
Of Attack

UPLAND — A sixth - grade teacher at the Main Street Elementary School has been charged with rape and contributing to the delinquency of a minor as a result of alleged [redacted] with one of [redacted] 12-year-old [redacted].

William J. Thorpe, 26, of 300 block of W. Minor Street West Chester, was arraigned before Upper Providence Justice of the Peace Dewey LaRocca Tuesday. He waived a preliminary hearing and was ordered held without bail for court on the charges.

Thorpe was arrested at the school by county detective Tuesday.

Detectives declined to reveal any of the details of the case.

The school board discussed the situation Wednesday night and suspended Thorpe until hearing at the Main Street School 7:30 p.m. March 1.

Teacher
Is Fired
At Upland

UPLAND—The school board fired a sixth-grade teacher at the Main Street Elementary School Tuesday night in connection with a morals case involving a 12-year-old [redacted].

The board, which had suspended the teacher last month after criminal charges were brought against him, said it was terminating his contract effective last Feb. 19.

William J. Thorpe, 26, of West Chester, has been charged with rape and contributing to the delinquency of a minor.

Chief County Detective Maurice L. (Bill) Maitland told the board Tuesday night Thorpe is to be tried in Delaware County Court on March 11.

In other action, the board authorized Supervising Principal Warren L. Whittaker and Solicitor Malcolm Petrikin to negotiate a contract with Ridley Township School District which has agreed to accept the borough's 10th through 12th graders next year.

The board voted to join with Penn-Delco and Garnet Valley School Districts in an Elementary-Secondary Education Act

Jailed in
Attack

MEDIA COURTHOUSE — An Upland sixth - grade teacher pleaded guilty today to raping one of his 12-year-old [redacted] and was sentenced to 2 to 10 years in Broadmeadows Prison.

Judge Francis J. Catana denied a defense plea for probation and ordered William J. Thorpe, 26, of West Chester to prison and fined him \$100.

Chief County Detective Maurice L. (Bill) Maitland testified Thorpe raped the [redacted] five or six times between December, 1965, and February.

Defense attorney Harold J. Hughes asked the court to place Thorpe on probation with the condition that he undergo psychiatric treatment.

A psychiatrist and 11 character witnesses appeared for Thorpe, who has been dismissed by the Upland School Board.

"This is the type of crime which shocks the conscience of a community," Judge Catana said. "Prison is the only disposition consistent with the ends of justice."
