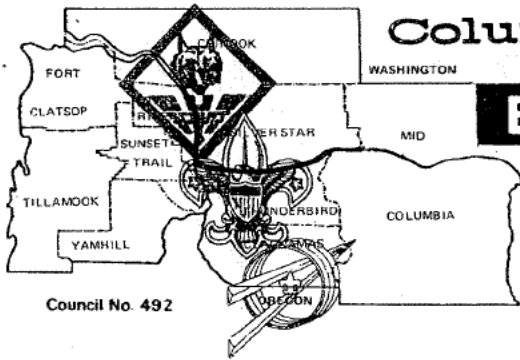

Dear Earl:

Sorry to be so long in getting you the necessary supporting information regarding David L. Kennedy, former Assistant Scoutmaster of Troop 235 of this council. This has been most difficult to do because of the determination of the Scoutmaster, [REDACTED], to avoid further involvement of boys and boys' parents and leaders in the case. It was Mr. [REDACTED] who first brought the matter to our attention and who, once it appeared there was a problem, despite a very deep affection and loyalty for Mr. Kennedy, insisted that he be the one to discuss it with Dave and take the necessary steps.

This he did, and was totally convinced that there was indeed a morals problem, and received Dave's voluntary retirement from the movement.

At the time of Mr. [REDACTED]'s confrontation with Dave, [REDACTED] identified the names of six young men who had been involved with Dave at various times over a four year period, primarily on camping trips, but on two occasions overnights spent in Dave's backyard. In each case it involved molestation of the young men by Dave. The names of the boys are: [REDACTED], [REDACTED], [REDACTED], [REDACTED], [REDACTED], and [REDACTED].

In addition to Dave's troop affiliation he had been extremely active in Order of the Arrow, having been Lodge Chief as a young man and later an adult counselor. We have no evidence to indicate that any problems arose out of his O. of A. activities, but of course he has now resigned from all elements of Scouting.

Unless we receive the above substantive material, we will not be able to keep this man's name on the Confidential File. Also, would appreciate knowing if this man is married or single.

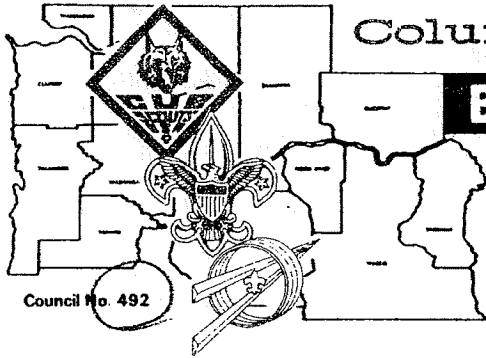
