I would like to call your attention to a matter that is of utmost importance to the well being of our young boys engaged in scouting in our area.

There is one man, namely Mr. George Kirksey, who lives on Kirksey Road, RFD address in our constant whom should be now and forever be forbidden to associate with any young boys.

I am a mother who speaks from experience with the knowledge that this man is mentally unbalanced in what we call our "social society" as far as his main reason for being with boys this age.

What I am trying to say, that at his hands my son was introduced at the age of 12 to nomosexual activities, and upon investigation on my part I found that due to 15 overtures to other boys in our troop they quit coming to the meetings.

Should you desire other names of those involved I will contact them and ask that they write to you giving their children's experiences with this man.
