I have discussed with you the fact that on a recent occasion I attempted to suggest to a Scout in another Troop that he might indulge in an indecent act with me, which was refused by the Scout, but I feel that under the circumstances that for the good of the Scouting Movement that I resign my position in the Boy Scouts of America. This I do with great regret, but under the circumstances I feel that it is the only honorable thing that I can do.

Dear Howard:

I request that one Assistant Scoutmaster, Mark Verloop, Troop 123, Santa Rosa, California, be put on the "Red Flag" list. Mr. Verloop lives at 1081 Janero Drive, Santa Rosa, and he has just attained the age of 21, and at present is unemployed.

Our records indicate that he registered as an Assistant Scoutmaster in Troop 123 in February 1967, a position which he has held to the present date.

Further information is that he wears glasses, is a round-faced individual with blonde hair, about 5'8" in height.

A complaint to me from a Scoutmaster and an Institutional Representative of another Troop in the Santa Rosa area indicated that Mr. Verloop had taken one of this Scoutmaster's boys and a friend to a local park for a ride and then a walk. He then had the Scout drop behind with him and attempted to fondle him and caress him in a manner that was quite obvious, with no good intentions. This has been substantiated by the boy's mother, as well as the boy, to me personally, even to the point that the Scout stated that Verloop asked that on his Scout's honor and the payment of a \$1.00 that he not discuss the advances made.

After a very complete investigation face to face with the individual, I asked that he resign from the Scouting Movement, and he fully understands that he will no longer be able to serve anywhere in our Movement. To this end I enclose, herewith, a letter which he signed in my office, and which was witnessed by my secretary, Mrs. Alice Handy.

I trust the above is sufficient information for your files.
