engaged in acts of sodomy with two Scouts of this Council
over a period of nine months. He became acquainted
with these boys at a public swimming pool, Lincoln pool,
in Santa Monica in activities not related to Scouting. He
is now confined to jail, to be tried in court in the near
future. The police sergeant, an old friend of mine, says
that there is no doubt since Ward confessed freely of his
acts with these two boys, and of others with boys aged
8 to 15.
