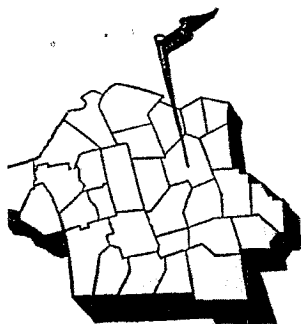
If you request further details, or a copy of the certificate of the conviction, Mr. Grife will send same to you upon his return, which will be the first week in April.
