

Sir:

As per your instructions, an immediate and intensive investigation was conducted by the undersigned with reference to allegations that Mr. Lyn Barton, Post Advisor, Explorer Post 347, Explorer Scouts, was indulging in Homosexual activities with a white male, age 21, named [REDACTED] III, who resides at 26 Lancaster Terrace, Hampton, Virginia.

Investigation disclosed the following:

Subject [REDACTED] III, Assistant Post Advisor, Explorer Post 347, was interviewed by me on February 4, 1965 at 2:45 P.M., and after having been advised of his rights, he stated that he and Mr. Barton had been masturbating each other since he was 15-16 years old (he is now 21), and that Mr. Barton has also sucked his penis on 3-4 different times since the last part of December 1964, the latest time having been at Mr. Barton's Office located at Multiple Listing Service, 2607 W. Mercury Blvd., Hampton, Virginia.

He also admitted that he has gone to auto races numerous times with Mr. Barton, that they would go by plane or car, and they have stayed in Hotels and Motels committing acts.

Mr. [REDACTED] signed statement is attached.

I interviewed Mr. Barton, after he agreed to come to Police Headquarters, and he read the statement of Mr. [REDACTED] and orally admitted that it was correct. He did not desire to give a signed statement. He stated that he would voluntarily resign from the Scouting Program, and seek help for himself.

He stated that he and Mr. [REDACTED] had also bought a house together, that he himself is not married and has no children. He stated that this is the only time he has engaged in this type of activity.

Both the membership Scouting cards of [REDACTED] and Barton are attached, and both of their resignations from the Scouting Program are attached.

I herewith submit report on the above case and the facts, so far as I am able to learn to date are:

The following statement given to Lt. H. C. Mapes by [REDACTED] III on February 5, 1965 at 4:00 P.M., after having been advised that anything he may state here can be used against him in Court, and also, that he has given this statement without being threatened in any way, or promised anything, and has given this statement of his own free will:

I first met Mr. Lynn Barton about 4 years ago. At that time he was an Explorer Advisor of Post 347. I was a member of Explorer Post 22 at the time, and I met him on a Camping trip in Williamsburg, Virginia. I met him during the normal Camping activities of the different Posts at Williamsburg at that time.

About 6 months later, I transferred from Post 22 to Post 347, and Lynn Barton was still Post 347 Advisor. As far as I remember, sometime after I joined Post 347, Lynn Barton and I were on a Camping trip with the rest of the Post, and somehow he and I got together and the both of us, in each others presence, masturbated. This was about the year 1958 or 1959, I believe. I cannot remember exactly.

I am still presently the Assistant Advisor of Post 347. Since the time I first went into Post 347, I have gone on different trips with Mr. Barton, and we have gone to auto races in Florida, South Carolina, and numerous other places, and sometimes we would stay in Hotels or motels overnight, and on some of the occasions, not all of them, we would be in the room together and masturbate each other.

This happened on numerous occasions, but I could not say exactly how many times. A few times it would happen where he works, at his Office, the Multiple Listing Service on West Mercury Blvd. in Hampton, Virginia.

About the last part of December of 1964, I let him put my penis in his mouth, because he wanted to do it. This happened only about 3-4 times since that time. This happened about the last time, about one (1) week ago.

I have often thought what the reason for this was, and I have often thought that this is not what I want to do.

I like and respect Mr. Barton as a friend, and I have sometimes felt that he was more or less like a second father to me, as he has helped me with my studies many, many times, and he has also instilled in me a desire to want to continue my education, which I am now doing, as I did drop out of High School three years ago, and am now studying to get my High School Diploma.

I also would like to state that I know there are no other Scouters doing this same thing, that I know of.

I would also like to be given the opportunity to voluntarily withdraw and resign from the Scouting Program.

I would also like to state that I have every intention to discontinue these practices with Mr. Barton.

I have read the above and have had it read to me and it is true to the best of my knowledge. I have signed this statement of my own free will.

At the present time we seem to be at a stand still about Mr. Barton. I have written to the Scout Executive of his present council, and apparently he is doing a good job, with no indication of anything wrong. Quite naturally, the Scout Executive is reluctant to do anything without some basic reason. Based on our past experience, we also are cautious. You and I know what a mess we get into when we place men on the file without sufficient proof. In the case of Mr. Barton, we cannot say to his present Scout Executive, that he must get him out of Scouting.

I am not pressing this at the moment, but if your men feel strongly enough and can come up with something definite, which they will put in writing, we will take it from there.

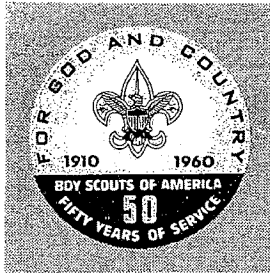

We have received a disturbing letter from the council where a Lynn Barton was formerly affiliated. He is now supposed to be a Scoutmaster in Newport News. We find a Mr. Barton listed as Scoutmaster in Troop #347.

He was asked to resign by his troop committee in 1956. They had several incidents happen which caused them to be suspicious of him and called him in for a hearing. According to our source of information he neither denied nor admitted anything. They relieved him of leadership and asked the council to take steps to keep him out of Scouting.

They admit they have no concrete proof but are disturbed that he is again in charge of a group of boys.

Please be cautious and discreet but find out what you can about him. We are not suggesting any action until we have some more facts.

Dear Basil:

I am writing to give you some information that one of our Scouters passed on to me yesterday concerning a Scout Leader who used to be in our Council. According to our Scouter this man's name is Lynn Barton. He is currently a Scout Master of a Troop in Newport News, Virginia (he could not tell me the Unit number). It seems that since the Jamboree he has been touring the West Coast with nine boys. He stayed approximately one week in Newport Beach. The story that I want to tell you is as follows:

It seems that he was Scout Master of Troop 17 in Newport Beach, sponsored by the Newport Beach Rotary Club, in 1956. This was just a year before my arrival in this Council. Through his actions and the way he operated the Troop several of the committeemen became rather suspicious that he might be working in Scouting for other reasons than good leadership to a group of boys. After a number of incidents which seemed to confirm their suspicions they called him in and questioned him concerning their apprehensions. He did not deny their apparent accusations nor did he admit that what they had accused him of was true. As a result of their meeting with him they relieved him of his leadership position and then I am told they made a formal request to the Scout Executive that his name be placed on the Confidential File. Up until this time the gentlemen who passed this information to me has been of the opinion that Mr. Barton's name has been in the file and he was, therefore, quite disturbed to have Mr. Barton show up here in charge of a group of boys.



At the time this request was made to Skip Fife he was very ill and perhaps someone on the Staff was handling most of his jobs so it is very possible that this was never properly handled. At any rate I told our Scouter that I would write to you to give you the story in order that you could check your files and perhaps you may want to investigate the man further where he is registered now. As I have said when the incident happened here they did not have and still do not have concrete proof that the man was out of line with the boys, but they felt strong enough about it to take the action they did. I can find nothing in our files regarding the matter.

If you would like to have a statement from the Scouters here who were involved I will ask them to comply. By the way, Mr. Barton was Scout Master of Troop 17 for approximately two years and was relieved of his position in the spring of 1956. He moved soon thereafter.



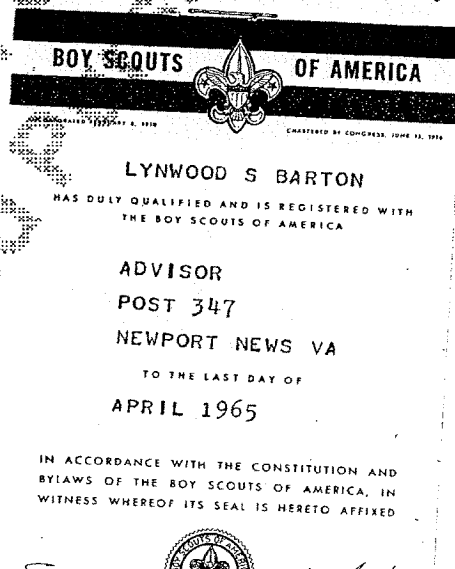
