I, John Irvin Baynard Blevins, make the following statement of my own free will, without any threats or promises from anyone, to Det. Penny and Leo Michiels.

My first time with homosexual relationship was at the age of 11 in Princeton, West Virginia, when I was to go to work for a milk truck driver in which to deliver milk to a rural route. On my first day at work, after we had started on the route, the driver tried to get me to have homosexual action. That was the first and only time until I entered the Armed Service.

After I went in the service I was assigned at Foster Air Force Base, Victoria, Texas. Due upon my arrival at Foster, I was propositioned by another homosexual, which was a Staff Serceant stationed on Foster Air Force Base, at the time of my arrival, He was the first person that I reported to, for signing in, when I tirst arrived at the Base. He invited me out for a couple of beers and upon the return trip to the base, he started fondling with my private parts, at which time I refused his proposition. This happened in 1957 around the 29th of July.

Around the 25th of September 1958, I was again propositioned by a homosexual while attending a movie at the Rex Theatre in Alexandria, which after I departed the theatre, he followed me out and down the street to the bus stop. He ask me if I was waiting to go back to the base and I told him yes. He told me he would drive me to the base. Upon the trip to the base he started talking about homosexual acts, and fordling my private parts. Then after a few moments he actually did the act of tellatio, on my person.

The next time i had homosexual relations was with an old fellow in which again, I was waiting for a bus to the base, and he stopped and asked me if Iwere waiting for transportation to the base, and he said he would take me to the base. Upon the trip to the base he started fondling my personal parts, and committed the act of fellatio. This was the only time I was with him.

On the first part of August 1958 I started to acting as a assistant Scoul Master with Troop 9 in Alexandria. After a few months joined the troop. The fhird time was after a Scout meeting about in back of May, then I committed my third act of fellatio. I he last of May, then I committed my third act of fellatio. Then on the 15th of August, Monday night, after a Scout meeting I carried to Camp Livingston and then committed my next act of fellatio. After the arrival at Camp Livingston I started fondling his private parts and after a while he started to crying. Then after I had fondled his personal parts he started fondling with mine. Then I took him home and returned homeomyself, and that's it I quess.
