Mr. Clark did while Scoutmaster of Troop 95, Transatlantic Council, on camping trips, take certain immoral, improper and indecent liberties with certain members of the unit and performed certain lewd and lascivious acts upon and with the bodies of certain children. Children so involved were under the age of 16 years. Accusations and admission show that the intent of Mr. Clark was to arouse, appeal to and gratify the lust or passions or sexual desires of the accused and the children.

Case investigated by U.S. Army Criminal Investigation Division, Northern Area Command, APO 757, New York, N.Y. since accused was a member of the U.S. Army. Accusations confirmed by admission during investigation. Records of case will be filed in Provost Marshal General, US Army, Repository, Ft. Gordon, Ga.

This man is expected to attempt reentry into Scouting upon release from U.S. Army through Salvation Army Youth Program.

Mr. Clark has been given an Undesirable Discharge from the U.S. Army as a Homosexual.
