

Comstock's Sentence Is Suspended

John Comstock, 33, former St. Albans Cub Scoutmaster, was given a two - to - three year suspended sentence in Franklin Municipal Court Friday, after he changed his plea from innoceat to guilty on a charge of lewd and lascivious conduct involving boys under 16.

One of the terms of his suspension was that Comstock not associate with persons under the age of 18, and further that he not return to the St. Albans area.

Comstock was also ordered to pay court costs of \$95.30 through the probation department.
