I haven't been in Ken Cordes' company in the past year. He has not particiapted in any of our Post activities for work than a year.



I had a session with him last night, of course, following our regular procedure of making no charges, but he told me why he thought we were taking this action and, of course, deried it. Through private sources I have found that his records of employment show at least one dismissal where homosexial tendancies were made a part of his record.

I believe that we will come up with something definite and concrete for you within a few days but in the meantime will you please delete his name from the records of the above units.

Incidently, I kope we do not have a rash of these things but you can save us a little time and yourself some postage if you will send us about a dozen of the confidential record sheets.
