Thomas E. Donahue came to the Sheraton Boston Hotel and the me in my room on Tuesday, May 20 at 10:30 A.M..

After preliminary discussion, Mr. Donahue readily admitted that he had received an undesirable discharge from the military service because of homosexual activities with two Scouts in Troop 20, El Paso, Texas. These activities consisted of acts of masturbation.

Mr. Donahue is 26 years of age and is still single.

I advised Mr. Donahue that there was little, if any, chance that we would be willing to ever again accept his registration in the Boy Scouts of America and that the only possibility would be the result of either denial of original facts, which is not possible in this situation, or written documentation from recognized medical authority and/or psychiatrist that he (Mr. Donahue) has completed treatment and that he is completely cured and such incident will never again occur.
