Dear Mr. Rowland:

Late September of 1964, one year ago, Lou Glinkman wrote us concerning James R. Eddy who had served as District Scout Executive on your staff from 1961 to 1963. He indicated that Eddy had been charged with immoral relationships with boys at the Colorado Boy's Ranch at La Junta, Colorado, and that a Mr. [redacted] Superintendent at the ranch indicated Eddy had made a full confession. In response we asked if it would be possible for someone to obtain a written statement from Mr. [redacted] concerning this situation, but to this we received no reply, probably because of the unfortunate accident which occurred to Lou.

I do not know why we waited this long to bring this up, but the fact that we had not heard from Lou has just come to my attention. Would you be willing to contact Mr. [redacted] on this matter and ask him if he would be good enough to give you a written statement that you could forward to us so that we could have it in our files? Your doing so would be greatly appreciated. Thanks very much.

Dear Sir:

In the summer of 1964 I was contacted in my capacity as Deputy District Attorney by Mr. [REDACTED] of this city. Mr. [REDACTED] teenage son told me that he and 3 other boys had been taken on a camping trip to San Isabel National Park by Mr. Eddy who was then an employee of Colorado Boys Ranch. The [REDACTED] told of Eddy committing homosexual acts upon him at a cabin at San Isabel. He also stated that he thought another boy had seen it. The other boy was interviewed but he denied seeing it and stated that he was asleep. The [REDACTED] boy also asserted that Eddy had had had relations with several other boys. This could not be verified. During the course of this investigation Mr. Eddy abruptly left the City of La Junta and this office has had no further contact with him. Insofar as I know Mr. Eddy was not questioned by any police authority concerning the incident complained of by the West boy.


Dear Sir:



I am writing concerning James R. Eddy who served as a District Scout Executive on the Staff of the Rocky Mountain Council from January 1, 1961 to August 15, 1963, at which time he resigned due to financial reasons.


After leaving our employment he held several short time jobs, then accepted a position with the Colorado Boy's Ranch at La Junta, Colorado. A month or more ago I heard that he had left the Boy's Ranch under somewhat incriminating circumstances.

While in La Junta last Friday I talked with a Mr. [REDACTED] Superintendent of the Boy's Ranch. Mr. [REDACTED] informed me that Eddy was dismissed on a charge of improper and immoral relationship with boys of the institution. He further stated that when confronted with the evidence Eddy made a full confession of his guilt.

In April of 1963 we had reasons to be suspicious of this young man. A complete and thorough investigation was made at that time, however the evidence was not complete nor thorough enough to convince us of his guilt. It now looks as if we were wrong.

In light of the above evidence I recommend that he be placed on the "Confidential List" immediately. If further information is desired I will endeavor to secure it.
