Man Accused by Boys Asks Help

Faced by three boys who accused him of improper acts, Leonard S. Gallagher, Sunday School teacher, Cub Scout Leader, and little league manager, broke down yesterday and cried "I'm sick. I need help."

The 27-year old man lives with his mother at 2024 Denison Avenue, S. W. He is an apprentice maintenance man for the Lewis Flight Laboratory of NASA.

The prisoner was arrested at work Morday and held without charge until yesterday, when charges were filed. The mother of one of the 25 to 30 boys who are accusing Gallaguer was told by her son about Gallaguer's activities. She called the police.

Seventeen parents at Central Police Station to give statements made a lunge for Gallagher when he was brought down from City Jail for questioning. Police pushed the prisoner into a side room until the parents left.

Gallagher, under \$10,000 bond, will have a preliminary hearing in Municipal Cour today.
