This letter is to request that the name of RICHARD D. CATES, registered as a Member at Large of this Council till October 31, 1961 be placed on the Confidential File at the Home Office.

Mr Gates is 34 years of age, approximately 51, 100 tall and weighs about 155 lbs. He has brown hair and hazel eyes. He currently resides at 77 Nicholas Ave, Morningdale, Mass. He is married and has two children. He is employed in a civilian capacity as a naval inspector.

He has served for the past two wars as Lag Advisor to the Council's Order of the Arrow Lodge.

He has been confronted with charges of homosexual activity with older boys in the Lodge, the serving of elcoholic beverages to certain of them in conjunction with the above, and the showing of pornographic risual aids (movies) to minors. The evidence has been checked out by the writer in personal visitation to some of the boys concerned with a third party present in each case. The activities alleged have transpired over at least a three-year period.

Mr Gates, when confronted today, admitted his guilt and has resigned from all further connection with Scenting here. No prosecution is contemplated by anyone.
