Dear Ken:

Your November 30 letter concerning Eugene W. Gray with the enclosed photo copy of your confidential record sheet dated March 15, 1962 concerning Mr. Gray has been received. I must admit that we are quite surprised.

We have checked our records very carefully and we find that we do not currently have Mr. Gray listed. Further, we carefully checked all of our previous records, in particular during the early part of 1962, and we find no record of ever having received the report concerning Mr. Gray (we keep a daily log of all reports received); nor do we find any record of ever having put him on the file (again, we keep a daily log); nor do we find any record that we ever took him off the file (here, a monthly record is kept).

I am not in the least bit questioning that you sent us this information on or about March 15, 1962, but what I am saying is that we have no record of ever having received it or ever having taken any action in connection with it. In short, we have nothing on him at all.

On the basis of the information you have currently provided we are placing him on our file as of now. His original case has now been made stronger by the reference in your letter of the current three cases of sodomy filed against him by parents of boys related to his "Young Ambulance Drivers' Club". This is all the evidence we need.

There is one further point I would like to raise, however, and that is what caused you to write your recent letter and send the photo copy of the record sheet? Did you have some cause to feel that we might not be listed on our file? If so, we would be curious to know more about it. Or, is he currently registered anywhere else and you found out about it and wondered why and how? Or, was there some other reason that prompted you to write your recent letter when, presumably from your point of view, you felt that you had already listed him with us? We would appreciate more information on this if you would be so kind.
