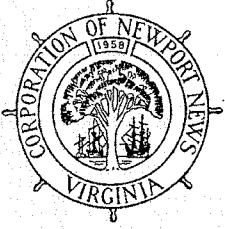

You will find attached two cards
from our local scout office for the above
subject.

The records show that in 1948
Mr. Hartley was tried in the City of Hampton
on three counts of Grand Larceny and was
given fifteen months on each count in the
State Penitentiary. On March 5, 1954 he was
charged with four counts of Contributing to
the Delinquency of a Minor. He was fined
\$25.00 and cost on each and given twelve months
on the State Road.

He was arrested on this date, April
22, 1964 and charged with being a fugitive from
York County. We have in our possession state-
ments from James Paul Morgan, age 15, of 625-
35th Street. He admits on several occasions
of having immoral acts with James C. Hartley.
The last time being last night in York County.

Mr. Hartley now is being held by the
York County authorities on these charges and

bond at \$1,500 has been set for his release if posted.

It is my recommendation that James C. Hartley be forever removed from the Boy Scouts of America, with his record and reputation, he should never be permitted to work around boys.

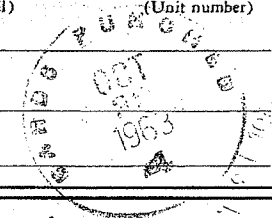
