He was arrested in Santa Ana in February 1962 for child molestation involving, among others, at least seven boys in the troop in which he was Assistant Scoutmaster. Mr. Hurt pleaded guilty and was committed to Atascadero State Hospital as a sexual psychopath. What I have provided you is a matter of public record.

Dear Mr. Taylor:

On February 8, 1962 a Richard Arlie Hurt, who resided at 1925C Adams Street, Orange, California, was arrested by this Department for felony child molesting.

Mr. Hurt, at the time of arrest, was registered as Assistant Scoutmaster of Troop 157, sponsored by the Sierra School P.T.A., Santa Ana, California. At least seven of the boys in Troop 157 were victims of Mr. Hurt's immoral conduct and part of the offenses occurred at Camp Myford.

Mr. Hurt entered a plea of guilty to Section 288 of the California Penal Code (Felony Child Molesting) in the Superior Court of Orange County on February 16, 1962. On March 9, 1962 he was committed, by the Superior Court, to the Atascadero State Hospital as a sexual psychopath.

This man is a homosexual and not a fit and proper person to be a Boy Scout leader. Therefore, we respectfully request that the above information be transmitted to the National Council of the Boy Scouts of America, that his name be placed in the Confidential File and that he never again be commissioned as a member of the Boy Scouts of America.

Thank you for giving this matter your attention and please be assured of our cooperation at all time.


