For the reason stated in the attached news story and is backed up by the Scoutmaster, [redacted], 210 9th Ave. So., Moorhead, Minn., and Pastor [redacted], 1224 So. 3rd, Moorhead, Walter Kise should be put on our confidential list and I so recommend.

Walter Kise was born May 10, 1935, has brown hair, brown eyes, weighs about 240 pounds, and comes originally from Brooklyn, N. Y.

He was a student at Concordia College, Moorhead, Minn., and since this incident was discovered word has it that he had been previously enrolled at Jamestown College, Jamestown, N. Dak.

Although he was caught recently there is rather strong indication that he had been molesting boys for about as long as he had been in town which is about 2 years.

Walter Kise was registered in Troop 36 Moorhead March 1958-59 but was not reregistered March 1959-60 although he was serving as assistant scoutmaster. He was immediately discharged of all responsibilities Monday, January 11, 1960 when his actions were discovered.

On your recent Transmittal Report #189 there was included the registration for Troop 269, District 1, Brooklyn. Applying for registration as an Assistant Scoutmaster was one Walter Kise of 1572 W. Sixth St., Brooklyn. He indicates that he is 28 years of age, Lutheran and his status is New.

We regret to advise you that we have information concerning Mr. Kise dating back to January, 1960 when he was living in Moorhead, Minnesota as a student. He was originally from Brooklyn.

Unfortunately, it now falls on you to tell Mr. Kise that the National Council does not wish to accept his registration in the Boy Scouts of America. If Mr. Kise should raise any questions as to reason, you should indicate to him that registration in the Boy Scouts of America is a privilege and not a right and that the National Council has the prerogative to accept those individuals it feels will best serve the interests of the organization.

We will refund his registration fee in a few days.
