I would like to submit to your section the names of two men to be placed on our confidential files. Each of these men had been registered in Scouting some time in the past, but are not now registered.

1. Ruben Livingston, Lubbock, Texas; Age, 22; Negro; 5 ft. 8 inches; Single. Was registered in 1962 as Assistant Scoutmaster in Troop #436. Sometimes called Danny. Convicted of Sodomy and received a five year sentence.
2. David Marvin Jackson, Lubbock, Texas; Age, 29; White; Single. Registered in 1955 as Assistant Scoutmaster of Troop #12 of Lubbock. Charged with two cases of Sodomy and check law violation. Case has not been tried as of this date.
