This additional information will enable us to identify Mr. O'Rourke should he ever again attempt to register in the Scouting program.

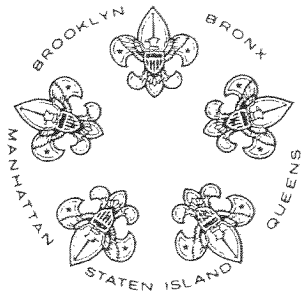


Dear Howard:


