

He is 22 years of age, currently with the U.S. Army in Vietnam, previously was active in Scouting when stationed at Fort Lewis, Wash. with the Tumwater Council at Olympia, Wash. He was active in Scouting as a boy in Gold Beach, Or.

This request is a result of a meeting with Mr. & Mrs. their son, age 9, had been assaulted by him in their home several months ago. William was a guest in their home, as his stepmother is Mrs. 's sister. He was contracted with this and there is no doubt as to the incident. He has had homosexual tendencies most of his life, he was under psychiatric care in Tacoma, while in the army and at the time he was sent overseas, he was under treatment.

His stepmother is aware of these tendencies and he promised her he would not get involved in Scouting again. Now the word is that his is deeply involved in Scouting in Vietnam.



The family is deeply concerned for the good of Scouting and also this was difficult for them as he has been in Scouting all his life and has an outstanding record as a boy and young adult leader.

If more information is needed, the s, perhaps could provide it. They gave me permission to use their name as they strongly feel this problem must be brought to the attention of the Boy Scouls of Americal
