Several weeks ago, Mr. George Martin, a teacher at Putnam Catholic Academy approached my Son offering his services to organize an Explorer Post in Brooklyn, Conn.

My Son [REDACTED] was elected President of the Explorer Post and Mr. Martin was chosen as advisor of the Post.

A close association was formed between Mr. Martin and [REDACTED] which resulted in homosexual advances by Mr. Martin. [REDACTED] immediately reported this to his teacher who in turn reported the incident to the Principle.

Both [REDACTED] and I were extremely upset by this incident and I felt it was necessary to report this to you to prevent further occurrences of this nature.

Mr. Martin was not yet registered in the post that he was going to be the advisor for. He was confronted by the father of the boy in question and his registration was withheld. The father happened to be the chairman of the troop thru which the post was being formed! The sponsoring organization was never involved.

The father notified the principal of the private school that the boy was attending. Because of the information received, the principal chose to releave Mr. Martin of his teaching duties, with no contest on the part of Mr. Martin. The principal chose not to involve the police in any way for fear of adverse publicity.

In reading over your correspondence, I am assuming that he really may not have ever been registered with you. Therefore, did someone approach him and tell him he could not be registered?

I am also curious as to whether he was relieved of his teaching position after being confronted with these facts, or whether he simply decided to resign because of these matters coming to the front and becoming public knowledge.

I also read that your information indicates that there was no arrest and no charges placed against him. Perhaps you can give me a little more background on the case and this will satisfy the information which we need for our permanent file.
