As far as I am concerned, you and your organization are the losers here; maybe eventually you will wisen up and admit that an error has been made.

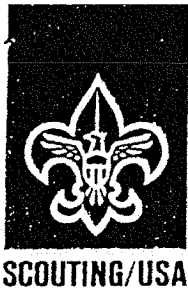

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

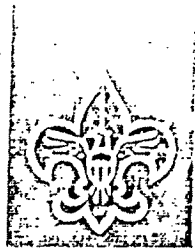

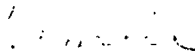

Dr. Bill Walker has resigned as Associate Advisor of Explorer Post 80 sponsored by Eighty Scouts, Inc..

Dr. Walker was accused of child abuse and homosexual activities on June 24th, 1979 by four families. No criminal charges have been filed at this time. Dr. Walker has been investigated by the Amarillo Police Department and has resigned all duties and connections with Explorer Post 80. He has admitted that the accusations are true.

In addition to this statement, is a statement from Charles Ritchie, Explorer Post Advisor for Post 80.

On Sunday, June 24, accusations were brought to me against Dr. Bill Walker involving homosexual child abuse. The parents reporting the alleged incidents chose to remain anonymous.

I presented this information briefly to Dr. Walker. We, in turn, met privately with each family involved and on Monday evening, June 25, Bill resigned all positions with Exp Post 8 & Eighty-Nine, Inc., our sponsor.

DEAN LOLLAR, SCOUT EXECUTIVE

THE LLANO ESTACADO COUNCIL, BOY SCOUTS OF AMERICA, ON BEHALF OF ONE OF OUR UNITS, HAS REQUESTED AND RECEIVED THE RESIGNATION OF AN ASSISTANT LEADER, AS A RESULT OF SOME INCIDENTS OF ALLEGED DEVIATE SEXUAL CONDUCT,

THE ACCUSATIONS HAVE BEEN INVESTIGATED BY THE AMARILLO POLICE DEPARTMENT, NO CRIMINAL CHARGES HAVE BEEN FILED, THE FAMILIES INVOLVED HAVE REQUESTED TO REMAIN ANONYMOUS, AS THEY FEEL THIS IS IN THE BEST INTEREST OF THEIR CHILDREN, THEY ARE SATISFIED WITH THE SWIFT ACTION TAKEN BY OUR COUNCIL AND THE PARTICULAR UNIT, THE LLANO ESTACADO COUNCIL, BOY SCOUTS OF AMERICA DEEPLY REGRETS THE INCIDENT,

OUR COUNCIL HAS TAKEN IMMEDIATE ACTION TO INSURE THIS INDIVIDUAL IS PERMANENTLY DISQUALIFIED FROM THE PRIVILEGE OF MEMBERSHIP ANYTIME IN THE FUTURE, OR ASSOCIATION WITH SCOUTS IN ANY CAPACITY OF LEADERSHIP, OUR NATIONAL OFFICE HAS BEEN ALERTED, SO THAT SHOULD THE INDIVIDUAL ATTEMPT TO BECOME AFFILIATED WITH SCOUTING IN ANOTHER CITY, THOSE LOCAL SCOUT OFFICIALS WILL BE NOTIFIED,

THE NATIONAL COUNCIL, BOY SCOUTS OF AMERICA RECENTLY STATED THAT "IT IS OUR POSITION THAT THE BOY SCOUTS OF AMERICA IS A PRIVATE ORGANIZATION AND MEMBERSHIP THERE IN IS A PRIVILEGE, NOT A RIGHT, WE RESERVE THE RIGHT TO DENY MEMBERSHIP TO INDIVIDUALS UPON THE BASIS OF OUR OWN STANDARDS, CONSISTANT WITH THE LAWS OF THE LAND", THIS INDIVIDUAL HAS FORFEITED THIS PRIVILEGE,
