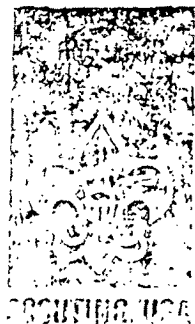

## Man Is Arrested For Assaulting Boy

A 29-year-old Boulder man was arrested Tuesday for sexual assault on a child after a 14-year-old boy complained that the man had forced him into sexual relations.

Ray Lewis Bieber, 7779 Devonshire Way, was arrested at the Boulder County Sheriff's Department, and released on a \$10,000 personal recognizance bond.

Bieber's arrest followed a two-month investigation into the claims of a 14-year-old Boulder youth who met Bieber through a Boy Scout Troop where Bieber was assistant leader.

The boy told detectives that a friendship with Bieber evolved into a sexual relationship last April which continued until Sept. 23, 1977.

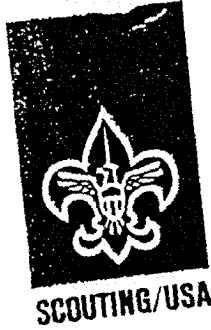

**NARRATIVE** (Nature of Report, Interviews, Investigation at Scene, Evidence, Footnotes, Status)

**NATURE OF REPORT:** P/O received a phone call from the complainant requesting a conference regarding a possible sexual assault on a child.

**INTERVIEWS:** P/O met with the complainant and witness who identified himself as Scout Master of Troop 377, sponsored by Heatherwood School. The complainant stated that he had been in contact with a Mrs. [REDACTED] who expressed her concern that her 14 year old son may have experienced some sexual activity with an assistant scout master of troop 377, identified as Ray Pieber. The complainant stated that he had spoke with Mrs. [REDACTED] and the victim on 10/3/77 which resulted in a meeting with the suspect on the evening of 10/4/77. During the conference with [REDACTED] it was learned that the victim had been experiencing severe emotional problems since the death of an older brother when the victim was 5 years old. Since that time the victim has had difficulty in sleeping resulting in Mrs. [REDACTED] sleeping with [REDACTED] until he turned 13 years of age. During this time [REDACTED] began to experience hyperactivity resulting in medication and special education. The victim began to sleep with the suspect at the Anderson residence due to the rewarding relationship being developed between the victim and the suspect.

The suspect had developed a relationship with the boy over the past year which included special scouting activities (a trip to the Bahamas) tutoring in scholastics and the purchasing of expensive items for the boy. On the evening of 9/23/77 the suspect was at the [REDACTED] residence sleeping with the victim in the victim's bed. It was related that David awoke finding the suspect molestating him. It was also related to the complainant that the suspect had performed anal intercourse on the boy.

9/26/77 - P/O held conference with Mr. and Mrs. [REDACTED] with the assistance of Mr. James Dean of the Department of Social Services. A conference was held at the Elk's Lodge, Boulder, Colorado at the request of Mrs. [REDACTED]. [REDACTED] stated that she was awakened by her son at approx. 2030 hours on 9/24/77. The victim appeared to be upset resulting in her asking what the problem was. The victim stated that the suspect was a "fag" and that he couldn't sleep with the suspect any longer. A few minutes later the suspect appeared observing that the victim was troubled. The suspect got dressed and returned to his own residence. The victim was not willing to relate specifics to his parents as to what actually occurred.

P/O held conference with the victim at the Department of Social Services with the assistance of John Dean of that agency. The victim stated that the molestations began to occur in April of 1977 continuing through the summer until the most recent occurrence on 9/23/77. The victim stated that on 9/23/77 the suspect was at the victim's residence assisting in school work when at approx. 2200 hours both subjects went to bed. The victim and the suspect would share the same bed and both were wearing underwear only. At approx. 2230 hours the suspect placed his hand underneath the victim's pants grabbing hold of the victim's penis. The suspect began to masturbate the victim for about 20 to 30 minutes according to the victim. The victim stated that the suspect may have thought the victim was asleep during the activity. The victim rolled over on his stomach to cease the molestation, however, the suspect then laid on top of the victim, placing his penis into the anal cavity of the victim performing anal intercourse. The victim stated that the suspect performed this activity for several minutes after which the victim got out of bed and informed his mother that the suspect was a "fag" and that he did not desire to sleep with the suspect.

The victim further stated that during the month of May, June and the summer of 1977 the suspect

nability. The victim's ability to get to sleep that night was caused by physical contact and  
not by a possibility of it. The judge's response was stating "you wouldn't believe the things I  
do to you when you are asleep".

It was thought by the victim that the suspect has been living in the Boulder area for approx. 15 years after transferring with ID# from "Page" House, New York. It was thought by the victim that the suspect had been a youth leader in four towns.

PA711177 - PFC Baldor signed with the aid of the Du-Lane County Sheriff's Department. The document is a bill of his rights per Miranda, which he waived those rights as indicated by the signed waiver form.

The suspect stated that he became acquainted with the victim during September of 1977 during Boy Scout activity. The suspect stated that he was an assistant Scoutmaster for the victim's scout troop during that time. The suspect stated that he became aware of the victim's scholastic problems through [redacted]. The suspect volunteered to assist David scholastically. The suspect began to work with the victim at the [redacted] on a regular basis. It was at the request of David that the suspect began to sleep with the victim with the knowledge and support of the parents. The suspect stated that on at least three occasions during the past year, David and he held conversations about sexual matters. The suspect stated that he viewed himself as a primary educator in sexual matters with David pointing out that the parents have not educated their son concerning these matters. David related some sexual experiences that he had had over the year which included sexual intercourse with females his own age. The suspect stated that David asked him about what type of sexual activity occurs between homosexuals resulting in the suspect going into detail explaining mutual masturbation and anal intercourse. The suspect related that he was unaware of any strained relationship between he and the victim who had including the date of 6/23/77. The suspect related that during the times that he was sleeping with the victim that he lost probably became in sexual contact with the victim, however, he states that if he did, it was unintentional. The suspect relates that he and the victim would sleep in the bunk waters which would cause the sleeping bodies to roll together. The suspect denies having made intentional sexual advances towards the victim. C/O requested

NATURE OF REPORT: R/O continuing investigation on above case.

DETAILS: R/O contacted the victims mother to arrange for a physical examination of the victim. R/O was informed by the victim's mother that the victim is currently on a hunting trip with his father and will return on 10/17/77. Contact will be made on that date to arrange for physical examination.

10/17/77 - R/O was contacted by the victims mother who stated that she would not allow the physical examination of her son in that she felt it was not in the best interest of her son. R/O advised                      that it was of essence to have a physical examination for the case investigation and that the physical exam would also test for diseases which the victim may have contracted during sexual contact. Mrs.                      again related that she did not feel the exam would be in the best interest of the boy and that she would not allow the examination to take place. R/O advised                      that most probably a court order would be sought to order the exam whereafter she continued to state that she would not allow the exam because it would not benefit her son.

10/27/77 - R/O contacted Judge Holmes who stated that insufficient grounds exist at this time to order the family to have their son examined by physicians.

11/9/77 - R/O contacted the parent of                      and made arrangements to meet with                      on 11/10/77.

11/10/77 -                      failed to show for appointment. R/O contacted                      who stated that he forgot about the appointment. It was rescheduled for 11/14/77 at 1515 hours.

David told                      that he went to his mother relating the incident which resulted in the suspect leaving the residence.

11/21/77 - R/O contacted Mr. Marchese at his residence and made arrangements for an appointment on 11/22/77 at 1000 hours.

11/22/77 - R/O held conference with                     , DOB 10/27/47, and                     , DOB 4/21/47. Mr.                      stated that he has two boys in the scout troop currently but has had no indication from his own sons of any sexual activity between the suspect and boys in the troop. Mr.                      stated that when he was informed of a problem with the suspect he did immediately connect                      as being a part of the problem due to the obvious close relationship between the two. Mr.                      stated that his brother,                     , worked with the suspect in East Fishkill, New York. Mr. Marchese was aware of a similar relationship between the suspect and a New York boy. However, it is not known whether any sexual activity occurred between the two. R/O requested Nick Marchese to contact his brother and attempt to obtain the name of the New York boy. This information would be available around 11/29/77.

NATURE OF REPORT: R/O continuing investigation on above case.

DETAILS: In reviewing the case, it was determined that the New York information would most probably be beneficial in prosecution of the case in this jurisdiction. Working through the District Attorney's Office, P/O processed an affidavit for the arrest of the suspect and obtain a warrant for his arrest through Judge Scott. The suspect would be referred to Community Corrections by the District Attorney's Office in lieu of criminal prosecution. It was stated to R/O by Mr. Bill Fritzel of the District Attorney's Office that if the suspect refused to cooperate with the Community Corrections arrangement, criminal charges would be filed. Arrangements were made by Bill Fritzel through the attorney of the suspect, Mr. Greg Martin, to have the suspect surrender himself to R/O on 1/31/78. Further, Mr. Fritzel recommended that R/O deliver to Community Corrections a copy of the case facts. R/O contacted Barbara Fitzgerald of Community Corrections and delivered to her the case facts. Ms. Fitzgerald requested that R/O meet with her on 2/10/78 to review the case history.

1/31/78 - The suspect appeared at R/O's office in the presence of his attorney for the purpose of arrest. The suspect was booked on charges of Sexual Assault on a Child and released to the Community Corrections Diversion Program. R/O advised the complainant of below disposition.

AFFIDAVIT FOR ARREST WARRANT

The affiant, Detective Richard Dutrow, a commissioned officer with the Boulder County Sheriff's Department, County of Boulder, State of Colorado, being duly sworn deposes and states that:

On 10/5/77, the affiant met with the complainant, Mr. Joseph Fisher, DOB 3/3/33, who identified himself as being scout master of Boy Scout Troop 377, Boulder, Colorado. Mr. Fisher stated to the affiant that he had been in contact with Mrs. [REDACTED] on 10/3/77 who expressed her concern that her 14 year old son identified as [REDACTED], DOB 4/6/63, may have experienced some sexual activity with an assistant scout master of Boy Scout Troop 377, identified as Ray L. Bieber, DOB 3/15/48. [REDACTED] stated to Mr. Fisher that her son, [REDACTED] had developed a relationship with Mr. Bieber over the past year which included boy scout activities, tutoring in scholastics and the purchasing of expensive items for [REDACTED] Mrs. [REDACTED] stated to Mr. Fisher that on the evening of 9/23/77 Ray Bieber was at the [REDACTED] residence assisting David with school work. Upon completion of the scholastics, Ray Bieber went to sleep with [REDACTED] in [REDACTED]'s bed. Later, Mrs. [REDACTED] was awakened by [REDACTED] who was noticeably upset. [REDACTED] informed his mother that Ray Bieber was a "fag" and that he "couldn't sleep with Bieber anymore". Mrs. [REDACTED] related to Mr. [REDACTED] that Ray Bieber appeared a few minutes later and observed that [REDACTED] was upset resulting in Bieber getting dressed and return to his own residence.

Mr. [REDACTED] related to the affiant that on 10/3/77 he spoke with [REDACTED] who related that he was sleeping with Ray Bieber at [REDACTED]'s residence, 7444 Old Mill Trail, County of Boulder, State of Colorado. [REDACTED] stated to Mr. [REDACTED] that he awoke to find Mr. Bieber masturbating him. It was also related that Mr. Bieber had performed a form of anal intercourse on [REDACTED].

On 10/6/77, the affiant met with Mr. and Mrs. [REDACTED]. Mrs. [REDACTED] stated that she was awakened by her son, [REDACTED], at approximately 0030 hours on 9/24/77. [REDACTED] appeared to be upset resulting in her asking what the problem was. [REDACTED] informed his mother that Bieber was a "fag" and that he couldn't sleep with Bieber anymore. A few minutes later, Bieber got out of David's bed and observed that [REDACTED] and Mrs. [REDACTED] were upset resulting in him getting dressed and returning to his own residence. Mrs. [REDACTED] advised the incident occurred at her residence located at 7444 Old Mill Trail, County of Boulder, State of Colorado.

On 10/6/77, the affiant held a conference with [REDACTED] at the Department of Social Services with the assistance of John Dean of that agency. [REDACTED] stated that the molestations began to occur in April of 1977 continuing through the summer until the most recent occurrence on 9/23/77. [REDACTED] stated that on 9/23/77 Ray Bieber was at his residence assisting in school work when at approximately 2200 hours both he and Bieber went to bed. David and Ray Bieber would share the same bed and both were wearing underwear only. At approximately 2230 hours, Ray Bieber placed his hand underneath [REDACTED]'s underwear, grabbing hold of [REDACTED]'s penis. Ray Bieber began to masturbate [REDACTED] for about 20 minutes according to [REDACTED]. [REDACTED] stated that Ray Bieber may have thought he was asleep during the activity. [REDACTED] rolled over on his stomach to cease the molestation, however, Bieber then laid on top of him placing his penis into the anal cavity of [REDACTED] performing anal intercourse. [REDACTED] stated that Bieber performed this activity for several minutes after which [REDACTED] got out of bed and informed his mother that Bieber was a "fag" and that he did not desire to sleep with Bieber any more. [REDACTED] further stated that during the month of May, 1977 he and Ray Bieber were in Bieber's vehicle en route to Boulder from Heatherwood Subdivision where a conversation ensued about David's sleeping habits. [REDACTED] related to Bieber that he could awaken easily by physical contact and not very easily by noise. Ray Bieber responded by stating "You wouldn't believe things I do to you when you are asleep." [REDACTED] further related that after his scout troop was presented a crime prevention program on child molestation in April of 1977, Ray Bieber stated to David that "Most people experience sex with both male and female."

On 10/11/77, the affiant interviewed Mr. Ray Bieber who after being duly advised of his constitutional rights per Miranda stated that he became acquainted with the victim during September of 1976 during boy scout activities. Mr. Bieber volunteered to assist [REDACTED] scholastically. Mr. Bieber began to meet with [REDACTED] at the [REDACTED] residence upon a regular basis. Mr. Bieber stated that on at least three occasions during the past year, David and he held conversations about sexual matters. Bieber stated that he viewed himself as a primary educator in sexual matters with [REDACTED] pointing out that the parents have not educated their son concerning those matters. Mr. Bieber stated that [REDACTED] asked him about what type of sexual activity occurs between homosexuals resulting in Mr. Bieber going into detail explaining mutual masturbation and anal intercourse. Mr. Bieber related

that during the times that he was sleeping with David that he most probably became in sexual contact with [REDACTED], however, he states that if he did it was unintentional.


On 11/14/77, the affiant held a conference with [REDACTED], age 15, 4636 Devonshire Street, Boulder, Colorado. [REDACTED] stated that on 10/10/77 he spoke with David [REDACTED] while at a scout troop meeting at Heatherwood Elementary School. [REDACTED] appeared very upset at the time relating to [REDACTED] that Ray Bieber "was a fag". [REDACTED] told [REDACTED] that while he was laying in bed with Ray Bieber, Bieber "did something" to David. [REDACTED] told [REDACTED] that he went to his mother relating the incident which resulted in Ray Bieber leaving the residence.

On 11/22/77, the affiant, through interviews of persons in the Boulder area, developed information that Ray Bieber had developed a similar close relationship with a New York State boy during the year of 1976 while Bieber resided in the vicinity of Poughkeepsie, New York. Investigation concerning that matter is continuing by the Boulder County Sheriff's Department and New York authorities.

The affiant feels that he has shown sufficient probable cause to believe that the defendant, Ray L. Bieber, DOB 3/15/48, described as being USMM, 5'9", 160 pounds, blond hair, blue eyes, residing at 7779 Devonshire Way, Boulder, Colorado, did in fact commit the crime of Sexual Assault on a Child, contrary to 18-3-405, C.R.S. 1973 as amended and requests that the court issue a warrant for his arrest.
