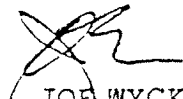
Attached you will find two documents which charge Dennis Crooks of 189 Cloverly Road, Grosse Pointe, Michigan 48230, with homosexual activity.

I am writing this document as proof. It may be used as needed to solve a problem with the questionable principles of a certain scouter. The certain scouter is Mr. Dennis G. Crooks.

It started back in 1973-1974. I was a scouter looking for a future in wrangling. My scout-master, Mr. Crooks was the head wrangler at D-A Scout Ranch on the weekends in the winter season. My objectives were to become a winter wrangler. Mr. Crooks had an interest in me because he was pushing me through the ranks so I could have enough experience in scouting to ride for him. Some of my duties to him were to receive the "Beard". The beard is an initiation or something like one where Mr. Crooks would rub his unshaven face on my chest until I gave up. I was not the only person to receive this treatment. Usually he would have someone hold the victim down while he proceeded to give the beard. I was holding people down for him after a couple of months of being subjected to the punishment.

At first the beard seemed harmless because it was done in the presents of many people. My first weekend as a wrangler, I went up to the ranch with; Mr. Crooks, [REDACTED] and [REDACTED]. On this weekend I was briefed on the practices of the winter wranglers, Such as drinking, "Specials", and what type of accidents on horses to report and to who. Drinking was not

a usual practice for me while I was at home. But the night I got to the ranch for the first time I was offered a beer. At the time I was offered, [REDACTED] already had a beer but [REDACTED] was not drinking. I took the beer and was required to give Mr. Crooks a special. A special was a backrub to be given to Mr. Crooks on request. If someone did not want to give him a special they were threatened with their job. I was threatened many times. The first couple specials I was required to give were done in the presents of other wranglers. So I got the feeling they were harmless. Eventually Crooks worked his way up to making me give them to him on Sunday afternoon when nobody was around. After a couple weeks of that, I was required to sleep in the same room as Crooks and give him a special while he was getting to sleep. If I resisted my job was threatened. I wanted to be a wrangler pretty bad so I always gave in. Usually after the special Crooks would turn around and pull me down off his back. I would have to lay on my back on his bed while he layed on top of me. If I was wearing a tee-shirt he would take it off of me. The first couple nights like this I would recieve the beard, but when I complained about the beard he promised not to give it to me any-more. Eventually I was catching on to why Crooks was pulling me down after the beard. I felt Crooks masturbating on either my leg or the corner of the bed. I knew it was happening but didn't know what to do. As far as I knew he didn't continue until ejaculation but there was the possility. While this was happening he usually fondled the upper half of my body.(Breast section) Many times he would swipe over my penis with his hand after pulling my legs closer. Many times he excited me until I had an erection.

I did not enjoy this treatment at all. Many times I would try a little resistance but he would threaten my job and I did not want to lose it. I was forewarned that when you are drunk Crooks makes passes at you while he is masturbating. Two of my friends; [REDACTED] and [REDACTED], had Crooks go into their under wear after Crooks asked them what they wanted at the moment. They answered a girl so he figured they were drunk and horny so he proceeded to play with their genitalia. When Crooks got me drunk one night I was asked what I wanted and all I would say is a car. He did not like that too much so he sent me to bed.

We drank at the ranch almost every weekend and usually it was to excess. Crooks would get angry if somebody would turn down a drink from him. Usually your job was threatened. One night [REDACTED] and I decided not to drink with Crooks. Instead we went to Glenn Datson's house for icecream. The two of us did not hear the end of that weekend for about a month. Crooks would tease us by saying to the other guys that we were not going to drink with them that night because we were going to have ice-cream.

We drank down in camp one weekend. We went to fair Oaks campsite before the cabin was built and downed a twelve-pack between about five of us in an hour. Crooks was rushing us because he was afraid of getting caught. We also drank at the picnic tables by the kitchen one weekend and we were pretty well schnokered. One night we went into town to the Whitehorse. Crooks was drunk before and after we went in, he was driving at close to 100 mph. on Metamora Road and 70 to 80 mph. on Sutton Road. I was so scared that I secretly buckled my seat belt,

if Crooks would have known that he would have been mad. He was mad at someone else who complained to him. There was drinking in the car at this time.

Another time that Crooks was drinking while driving was in January of 1977, Crooks had just got back from California and called me on a Saturday night. He wanted me to go to the ranch with him. I objected and he threatened my job. I was so worried I brought my mom into the picture by telling her that he wanted me to go because we were going to drink. She didn't know what to do so she told me to go and save my job but to watch myself. I never got sick from drinking with Crooks but this night I came close. On the way out he stopped at a liquor store and bought two bottles of "Old English 800". They were quart size and he had his gone pretty fast. I did not want to get drunk so I drank real slow. When we arrived at the White-Horse Crooks made me guzzle the half quart I had left. We went in and he was talking to his friends. He had ordered a drink and left it on the table. The malt liquor hit me like a kick in the head, I started to nip on Crooks's drink. When we got back to the ranch he asked for a special and I was feeling kind of sick so I told him NO! He was pretty mad and started to threaten me but I came to realization that wrangling was too much hassle. After that weekend [REDACTED] and I started to think about coming up on our own and working maintenance when Crooks was there. Crooks threatened [REDACTED] that he would tell on us to Mr. Wykoff if this was to happen. He thought that we were on our own under the age of 18. We had friends that were up at the ranch that were 19 and 20. [REDACTED], [REDACTED] and [REDACTED] were examples.

Many times when we would drink with Crooks we would drink to get drunk. I was at the age of 15 when I started to drink with Crooks but there were a few people younger than me. [REDACTED] was only 12 or 13 when Crooks was feeding him alcohol and he usually was getting drunk with us "older guys". Many people would get sick when they drank with Crooks. Sometimes we went three or four weekends in a row that at least one person would get sick from an over consumption of alcohol.

I am writing this document for the future wranglers of D-A. Everything I have included in this report is absolutely true! I would like to see this man expelled from scouting because of what he may do in the future to other innocent young scouts. I was not hurt by his actions as far as I know but someone may get hurt in the near future.

This report may be used as needed by Mr. Glenn W. Datson. I may have forgotten plenty but I hope this is enough to prove the guilt of the party involved. I would like this report to be kept confidential unless otherwise told by me.

I, [REDACTED], submit the statements within as proof of certain actions of one, Mr. Dennis G. Crooks. The problems that have arisen from these doings have brought about question of the character of Mr. Crooks as a leader in the Boy Scout organization.

The program began as a sort of game to show the younger scouts. Mr. Crooks discussed this with other scouts, usually when alone with them, out of which some were my friends. I never got beyond the planning stages with me perhaps because I voiced some question of why he wanted to do this. I never heard of it going any farther with any of the others. This game entailed getting dressed in a bathing suit and being tied to a table or tree. Then he was to put ketchup on the boy to make it look like he was being tortured. When this was done Mr. Crooks was to take a picture of this to show the other scouts if they weren't good.

After this there was the beard. Crooks would joke about us, the boys he brought up, giving him trouble and then he would take the "trouble maker" and rub his unshaven chin on the boys' bare chest until it hurt. When it hurt he would ask us if we had enough. He would talk to us in a way that ~~and~~ make us feel like we were tough if

we could take it. I got to be something of a game or competition between me & my friends and Crooksmen this and he would bring it up while doing it to see who could last longer. He did this sometimes in front of others by having them hold the one down and in this way we were set at ease by having our friends around and we didn't think anything was wrong with it. He would also do this at his home or at camp when he was alone with a dog. After a number of times of this he would sometimes, seemingly by accident, brush his hand below the belt while giving the beard. Sometimes while giving the beard he would be laying on the edge of the couch or bed and be making w. up & down motion which now I can see was part of the reason for his excitement.

Then on different occasions, he started asking me to give him backrubs and many times he would give me the beard after this. From talking to my friends at this time like many other times I found that the same had happened to them & in the same fashion. Around this time is when I had been going up to D.K. for the first times as wrangler with a number of other guys from the troop. He did not keep me anything to think besides pop the first couple of times saying that

I could drink when I became one of the guys. He did buy some of the others something to drink and they were not of age. There were times on the way to camp that he would buy for the guys and he himself would be drinking and driving. I have been in the car while he has been driving after ^{having} many drinks. Soon after a few times with the group he started to buy me what I wanted to drink. He would be sitting in his bedroom at the Health Lodge. He would have already locked the main door and he told us to lock the bedroom door and slide a bed in front of it. He told us that if anyone came in to hide all the drinks just sit and talk. Glenn never happened in though. Sometimes we would do it at a cabin in camp or drive out to a campsite at night & drink there. If it wasn't convenient to dispose of the trash properly he would tell us to pitch the bottles and what not into the woods. One time he got angry when I didn't want to throw trash out the window on the road so I threw it out before he got really mad.

When told to I would sleep in the blue room of the Health Lodge with him. All of the guys with him at the time would

get pretty thoroughly drunk and then he would tell us not to go to bed.

When I was in bed with just my undershorts on he would ask me to give him a "special" which was a back rub. This led to him giving me the beard. When very drunk I didn't think much of his hand working down to my shorts. He would start asking me things like, how do you like the new bridle I bought you, and did I want to drive his car the next day. I thought that it would be great because I didn't have my license and wouldn't for another 2 or 3 years.

This is the process he would use and he would end up playing with me through my pants. Each time this happened he had bought stuff for the group to drink and by the time we got to bed all of the boys at least were drunk. I never really drank before I started going to camp with Mr. Crocker so I could say this is when I was introduced to drinking, being drunk, and getting a hangover. I found myself very relaxed in the things I did on these occasions but never got so drunk that I couldn't remember the night before. These occasions soon ended up being most every weekend during the wrangling season.

Then came a weekend in the same sort of situation as the times before. Mr. Crooks asked me to give him a backrub and that went to the beach. This time though he started asking me what I wanted more than anything else. I felt uneasy and told him I did. He laughed and asked if I had a girlfriend & wouldn't I like to be with a girl. I layed there feeling helplessly drunk just slurring my speech. He had been playing with me through my underpants but now he took them off of me & started playing with me more. I could feel his erection on my leg through his shorts. He took hold of my penis and started masturbating me. I ejaculated and he said OK [REDACTED] that's all, go back to bed. So I went to bed & to sleep. All through this he kept talking and tried to keep me talking. He talked mostly about camp and the things he had done and would do for me. He never exposed himself to me and I never knew of him taking his pants off. His hand was the only thing that ever touched my penis. I never got a hard on until he started feeling around that area. The next day he acted as if nothing had happened. He said nothing of it. He let me drive his car and ride the horse I wanted the next day. I was confused and loved it.

wouldn't happen again. This was the first time something like this had happened to me and though it had felt good I hated it for a reason that was unclear to me then. I had hoped I wouldn't have to deal with this problem again.

It happened a second time under the same sort of circumstances and being very drunk. He masturbate me and I ejaculated. I was sorry I had let it happen again but this time before he left ~~to~~ he said it had gone too far and I agreed with him. After that I didn't believe it would happen again but I made up my mind not to let it incase it did. He did try it again under the same circumstances of my being drunk. His hand started going down to my genital area once more. At this point I told him I didn't think we needed any of that to be good friends. After asking me a couple of questions which confirmed to him what I was saying. He then got angry and rising his voice said "are you ~~even~~ making me out to be a God damned faggot?" He told me to get to bed ~~and~~ fast; switching bedrooms, and told me to forget all the things he was going to do for me. He said he would be there for a real friend. I said fine and went to bed. After that weekend

I still went up with him & the others to wrangle but I never got the same special treatment that I got before.

I'm glad I did what I did and I'm sorry I didn't do it earlier. After two other guys protested against what he was doing when they found themselves in a similar situation he pretty much dropped the group of guys that he had been taking up and got a new group that knew less of these happenings than we did. For this reason of not knowing the new guys I do not know if he has continued these ways but I am much more willing to believe he has than not. I'm sure I can not remember all that has passed but what I have just written is all fact. This is the main reason for my interest in having this situation taken care of for I feel that even though it has not had a permanent effect on me in an adverse way, I feel that it could cause harm someone if they are caught in a situation such as the one I have described. Mr. Crooks has done many good things but none of which justify these actions I have just stated. I feel his involvement in scouting easily furnishes an environment that will bring about a continuement of these actions.

and myself helped tie [REDACTED]

him the beard. [REDACTED] I saw Mr. Crooks
apparently masturbating on the edge
of the bed. It is only "apparent"
because he was fully dressed. This
happened before I had gone through
anything more than the specials.

All that has been written here is
