
Dear Joe,

To Whom it may Concern:

June 8, 1970, Schiltree County Attorney informed my office that two boy scouts and their fathers would be contacting me in reference to a scout official named Don Seigler. They alledged that Seigler forcibly contacted their genitals on an outing trip to Colorado. Don Seigler and the two fourteen year old scouts were the only parties involved in the trip to Colorado when the alledged conduct occurred.

Written and voluntary statements were taken from the two boy scouts. The statements were taken separately and before a justice of the peace. The statements are written by the youths in their own hand writing. The magistrate made a determination that the boys made the statements voluntary and intelligently. The statement from the boys said that Seigler made hand contact to the genitals on both of the fourteen year old scouts.

Criminal charges would have been brought against Mr. Seigler from our county attorney, but the offense alledgedly occurred in Colorado. Sorry I can not enclose the statements from the two boy scouts. In my opinion, the boys were telling the truth in this matter.

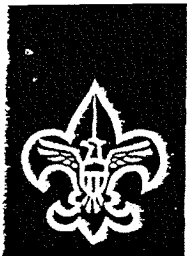

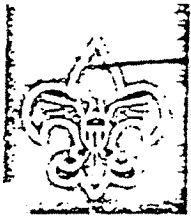

Board member Hardy and Assistant Scout Executive Cox informed Institutional Representative, Harold Hudson, whereupon, a subsequent Troop Committee meeting was called by Mr. Hudson, which resulted in a member of this committee, making a visit with Mr. Don Seigler to ask for his resignation. Mr. Seigler resigned the position of Scoutmaster without explanation.

Mr. Seigler has served as Assistant Scoutmaster for Troop 249 each year since 1974 and "assumed" Scoutmaster position since Scoutmaster Wayne Hutson had moved away, recently.

Institutional Representative Harold Hudson, Board member Ernest Hardy, and Staff Member Cox are to be commended for the expeditious and discrete manner in which this troop leadership problem was handled.

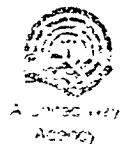
