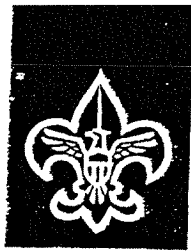

Dear Mr. Bumbalo:

This letter is in response to your letter to me of February 10, 1978 relative to the above individual. I cannot give you a certified copy of an investigation or disposition in this case. However, I will tell you what I feel I can and hopefully that will suffice.

Mr. Von Neida was charged with Sexual abuse in the second degree in violation of Section 130.60 of the Penal Law. He pled guilty to this and was sentenced to a three year term of probation. One of the terms of his probation being that he seek assistance in trying to overcome this problem.

He did not actually perform any abnormal sexual acts with the boys. However, what he did was a criminal offense and is not desirable behavior for an adult man in the Boy Schouts before his Scouts.

I have furnished you with all I feel I can. I also will tell you that he was in my opinion truly remorseful of this and regretted having done this. He was fully cooperative and actually acted as if he wanted help. Unless you have some assurance that he has overcome this problem, it would be my suggestion he not have any contact with young boys which is not supervised by another adult. I hope this information is sufficient. Thank you.
